BRIEF DISCUSSION BY ALLEN ZEMAN REGARDING MOTORCYCLE ISSUES ON STATE ROAD A-1-A AND COMPILING A LIST OF CONCERNS TO STEVE GLASSMAN. PRELIMINARY CONSIDERATIONS ARE AS FOLLOWS:

REPLACING LIGHT OR ELECTRIC METER ON N.E. 21ST STREET ENTRY FEATURE

GAS LEAK IN AREA OF 3031 NE 22ND STREET

A COMPREHENSIVE LIST SHOULD BE COMPILED AT THE NEXT MEETING FOR PRESENTATION TO COMMISSIONER GLASSMAN AS HE HAS REQUESTED.

DON POOLE RAISED QUESTIONS REGARDING SHORT-TERM RENTALS AND WAS ADVISED THAT THE CURRENT LEGISLATION ALLOWS FOR THEM WITH CONDITIONS OF USE TO PREVENT EXCESSIVE NOISE AND PARKING ISSUES, ETC.

NEW BUSINESS

ALLEN ZEMAN DESCRIBED THE PROPOSED VACATION OF N.E. 32ND AVENUE SOUTH OF N.E. 19TH STREET WHICH HAS BEEN SUBMITTED TO THE DEVELOPMENT REVIEW COMMITTEE OF THE CITY OF FORT LAUDERDALE. THE PROPOSAL IS DETAILED AND ON FILE WITH THE CITY, AND MAY BE DOWNLOADED AT

SEVERAL MEMBERS INCLUDING GEORGE FUSSELL & PETER DESIDERIO EXPRESSED CONCERN REGARDING THE RISK OF LOSS OF ACCESS, COST TO THE ASSOCIATION. JACK CUMMINGS DESCRIBED SOME OF THE HISTORY

AND HAD SOME POSITIVE THINGS TO SAY ABOUT THE PROPOSAL, BUT WAS ALSO CONCERNED ABOUT A POTENTIAL CHANGE IN ACCESS.

JAMES AKERS PROPOSED A MOTION FOR A VOTE AT APPROXIMATELY 8:00 PM; AS SUPPORT FOR THE VACATION OF N.E. 32ND AVENUE WAS APPROVED BY A 14-1 VOTE IN EARLY 2018 BY THE HOA, THE MOTION WAS STYLED AS A WITHDRAWAL OF DIHOA SUPPORT FOR THE PROPOSED VACATION OF N.E. 32ND AVENUE. CRIS BOEHLER SECONDED THE MOTION. SOME OF THE ZOOM MEMBERS HAD SOME DESIRE TO CONTINUE DEBATE ON THE SUBJECT, SO THE MOTION WAS REVISED MY JAMES AKERS TO A NON-BINDING VOTE TO DETERMINE THE VOTING NUMBERS, FOLLOWED BY A VOTE TO BIND BY A SHOW OF HANDS. THIS MOTION WAS SECONDED BY MR, NASH, THE VOTE WAS TAKEN INDIVIDUALLY BASED ON THE ATTENDANCE SHEET, IN PERSON AND VIA ZOOM. THE FINAL COUNT WAS A 45-4 VOTE IN FAVOR OF WITHDRAWING DIHOA SUPPORT FOR THE VACATION OF N.E. 32ND AVENUE WITH AKERS, PAGE, & 2 KUSHNER VOTES IN DISSENT. THE VOTE WAS THEN CERTIFIED WITH A SHOW OF HANDS THAT AFFIRMED THE WITHDRAWAL.

ALLEN ZEMAN STATED THAT HE WOULD BE WITHDRAWING THE VACATION ENTIRELY TO AVOID ANY FURTHER ISSUES.

NEXT MEETING AND ELECTIONS ARE TENTATIVELY SCHEDULED FOR LATE MARCH EARLY APRIL 2021 TO BE ANNOUNCED AT A LATER DATE.
